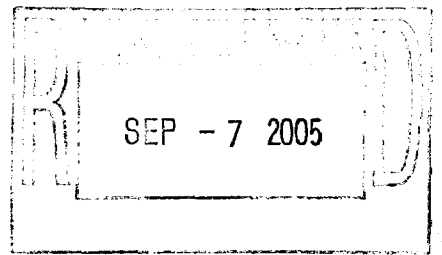

ASSIGNMENT OF TRADEMARK




