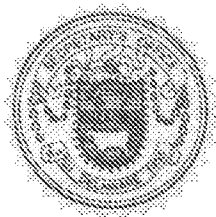

**RESOLVED**, that the Certificate of Incorporation of the Corporation be amended, so that Article 4 thereof shall read, in its entirety:


