CONFIRMATORY TRADEMARK ASSIGNMENT

WHEREAS on May 13, 1983, Thermacore, Inc., a Pennsylvania corporation with its principal place of business located at 780 Eden Rd., Lancaster, Pennsylvania 17601, applied to register the mark THERMACORE (U.S. Registration No. 1,317,936) (the "Trademark") with the U.S. Patent and Trademark Office (the "USPTO");

WHEREAS on February 5, 1985, the USPTO registered the Trademark on the Principal Register;

WHEREAS in July 1997, Thermacore, Inc. assigned its trademark registration to its intellectual property holding company, Thermal Corp., a Delaware corporation with its principal place of business located at Wilmington, Delaware 19801;

WHEREAS since the above-referenced assignment, Thermacore, Inc. has made exclusive and continuous use of the Trademark;

WHEREAS sometime between July 1997 and January 2005 Thermal Corp. assigned the Trademark back to Thermacore, Inc. without recording an executed assignment document with the USPTO;

WHEREAS Thermal Corp. now wishes to confirm the aforementioned assignment of the Trademark and its registration to Thermacore, Inc. and record a copy of such assignment with the USPTO;

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, Thermal Corp. ("Assignor") confirms the grant to Thermacore, Inc. (the "Assignee"), of all right, title, and interest in and to the Trademark and its registration in the USPTO, along with the goodwill of the business associated therewith.

The Assignor does hereby confirm the assignment unto the Assignee of all of its right, title, and interest in and to the Trademark and its registration therewith, free and clear of all liens and encumbrances, together with all of the goodwill of the business associated with and symbolized by such Trademark, the registration thereof and therefor, and any rights of the Assignor to sue any third parties for any past infringement of or to the Trademark, for the use and behoof of the Assignee and its successors, assigns or other legal representative and to prosecute such registration in the USPTO.

After the execution of this Confirmatory Trademark Assignment, at the request of the Assignee and at the Assignee's expense, but without additional consideration to the Assignor, the Assignor will execute and deliver to the Assignee from time to time such further instruments of conveyance, transfer and assignment and other documents, and will take such other actions, as the Assignee may reasonably require to convey and deliver more effectively to the Assignee the Trademark, to perfect the Assignee's title thereto, and otherwise to accomplish the orderly transfer to the Assignee of the Trademark and to give full effect to this Confirmatory Trademark Assignment. This Confirmatory Trademark Assignment is binding on the Assignor and its successors and assigns, and inures to the benefit of the Assignee and its successors and assigns.

IN WITNESS WHEREOF, intending to be legally bound hereby, the Assignor has duly executed this Trademark Assignment as of this 20th day of December, 2005.
