TRADEMARK ASSIGNMENT

WHEREAS, AFM Corporation, a Minnesota corporation, having a principal place of business at 211 River Ridge Circle, Suite 102, Burnsville, MN 55337 (hereinafter "Assignor"), has adopted, used, and is using the mark DIAMOND SNAP-FORM SYSTEM (and its derivative DIAMOND SNAP) in its business and which is registered in the United States Patent and Trademark Office as U.S. Registration No. 2,006,660 (the "Mark"); and

Assignor hereby sells, assigns, transfers and sets over unto Assignee all of Assignor's right, title and interest, anywhere in the world, in and to the Mark and the registration therefor, together with the goodwill of the business in connection with which the Mark is used and that part of the goodwill of the business connected with the use of and symbolized by the Mark;
- 2. Assignor further covenants and agrees that it will, at any time upon request, execute and deliver any and all documents that may be necessary or desirable to perfect Assignee's rights in and to the Mark; and
- 3. This Assignment includes any and all rights to, use for and recovery of all damages for infringement of the Marks, past and future, and the causes of action therefor. Further, Assignor agrees to cooperate in any such actions to the extent reasonably required by Assignee to enforce the rights transferred hereunder.
