NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, BOSCH hereby ratifies and affirms that certain Assignment and Bill of Sale, dated July 25, 2003, pursuant to which BOSCH assigned to FOREST, and CREDO hereby assigns to FOREST, all right, title and interest in and to said trademarks and registrations

therefor, together with the goodwill of the business symbolized by said trademarks and registrations therefor, all causes of action for damages by reason of past, present or future infringement thereof, and all income, royalties or payments due as of the date hereof or hereafter.
