**CERTIFICATE OF OWNERSHIP AND MERGER  
OF  
ALFLEX CORPORATION, a Delaware corporation ("Subsidiary")  
WITH AND INTO  
SOUTHWIRE COMPANY, a Delaware corporation ("Parent")**

Pursuant to Section 253 of the General Corporation Law of Delaware, the undersigned SOUTHWIRE COMPANY, a Delaware corporation incorporated on December 3, 1992, does hereby certify that it owns 100% of the capital stock of ALFLEX CORPORATION, a Delaware corporation incorporated on June 29, 2000, and that Southwire Company, by a resolution of its Board of Directors duly adopted at a meeting held on November 9, 2005, determined to and did merge into itself Alflec Corporation, which resolution is set forth below:

WHEREAS, SOUTHWIRE COMPANY ("Southwire") owns 100% of capital stock of ALFLEX CORPORATION, a Delaware corporation ("Alflex"); and

WHEREAS, Southwire desires to merge into itself Alflec, and to be possessed of all the estate, property, rights, privileges and franchises of Alflec;

NOW, THEREFORE, BE IT RESOLVED, that Southwire merge into itself Alflec, and that Southwire assume all of the liabilities and obligations of Alflec; and

FURTHER RESOLVED, that the surviving corporation of the merger shall be Southwire; and

FURTHER RESOLVED, that an authorized officer of Southwire is hereby directed to make and execute a certificate of ownership and merger setting forth a copy of the resolution to merge Alflec with and into Southwire and assume its liabilities and obligations, and the date of adoption thereof, and to file the Certificate in the office of the Secretary of State of Delaware and a certified copy thereof in the office of the Recorder of Deeds of New Castle County, Delaware; and

FURTHER RESOLVED, that the officers of Southwire be and they hereby are authorized and directed to do all acts and things, whether within or without the State of Delaware, which may be in any way necessary or proper to effect the merger
