## ASSIGNMENT OF TRADEMARK

THIS ASSIGNMENT, effective as of **December 1, 2005**, is from **GENLYTE THOMAS GROUP LLC**, a Delaware Limited Liability Company with a business address of 10350 Ormsby Park Place, Suite 601, Louisville, Kentucky 40223 (“Assignor”), to **CANLYTE INC.**, a Canadian Corporation with a business address of 3015 Louis A. ### WITNESSETH:

WHEREAS, Assignor is the sole owner of the exclusive right, title and interest in and to the trademark GENESYS and registration thereof (U.S. Reg. No. 2,342,370) (hereinafter referred to as “the Mark”);

WHEREAS, Assignee is interested in acquiring the entire and exclusive right, title and interest in and to the Mark and registration thereof, together with the goodwill of the business connected with the use of and symbolized by the Mark;

WHEREAS, Assignor desires to assign to Assignee, and Assignee desires to receive from Assignor, the entire and exclusive right, title and interest in and to the Mark and registration thereof, together with the goodwill of the business connected with the use of and symbolized by the Mark;


NOW, THEREFORE, in exchange of good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby assigns to Assignee:

1. The entire and exclusive right, title and interest in and to the Mark and registration thereof, together with the goodwill of the business connected with the use of and symbolized by the Mark, including the right to register the Mark in Assignee’s name throughout the world; and
2. The sole right to enforce rights in said Mark and registration thereof, with the right to sue for and recover for Assignee’s own use accrued profits or damages for any and all causes of action, claims, and demands and other rights for infringement thereof, including, but not limited to past infringements with respect to which Assignor waives any right to receive any portion thereof.

Assignor covenants that Assignor has the full right to enter into this Assignment and further agrees without further consideration to cause to be performed such other lawful acts and to be executed such further assignments and other lawful documents as Assignee may from time to time reasonably request to effect fully this Assignment and to permit Assignee to be duly recorded as the legal and record owner of each of the rights hereby conveyed.


