RELEASE OF SECURITY AGREEMENT

THIS RELEASE OF SECURITY AGREEMENT (this "Release") is made and effective as of September 21, 2005 ("Effective Date") by and between ZIONS BANCORPORATION ("Bank") and IDENTRUS, INC. (As Successor-in-Interest to IDENTRUS, LLC), a Delaware Corporation ("Borrower").

WITNESSETH

WHEREAS, pursuant to the terms and conditions of that certain Bridge Loan and Security Agreement, dated as of March 14, 2005 (as amended and/or supplemented from time to time, the "Security Agreement"; capitalized terms used herein and not otherwise defined are used as defined in the Security Agreement), between Bank, Borrower and the other Lenders named therein, Borrower granted, assigned, transferred and pledged to Bank and to the other Lenders named therein a continuing first priority security interest in all of its right, title and interest in and to the Collateral, including without limitation the trademark registrations and applications set forth on Schedule 1 hereto, the patent registrations and applications set forth on Schedule 2 hereto and the copyright registrations and applications set forth on Schedule 3 hereto, together with the goodwill associated therewith;

WHEREAS, the Security Agreement and/or the liens granted thereunder were recorded with the: (i) Trademark Division of the U.S. Patent & Trademark Office on March 18, 2005 at Reel 003070, Frame 0474 and on March 21, 2005 at Reel 003072, Frame 0059; (ii) Patent Division of the U.S. Patent & Trademark Office on March 18, 2005 at Reel 015932, Frame 0591; (iii) U.S. Copyright Office on March 22, 2005 at Volume 3520, Document No. 714; and (iv) the Secretary of the State of the State of Delaware, on Form UCC-1 (File Number 50865734); and

WHEREAS, Borrower has paid in full all of its Obligations.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Bank on behalf of itself and for the ratable benefit of the other Lenders hereby terminates, cancels, re-pledges, reassigns and releases any and all security interests it has against the Collateral, without warranty or recourse.

The Bank shall take all further actions, and provide to Borrower and each of its successors, assigns or other legal representatives, all of such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), requested by Borrower to more fully and effectively effectuate the purposes of this Release.

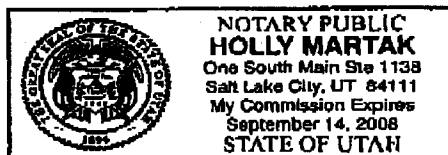
