1. I, Marco J. I do hereby further certify that pursuant to the provisions of Chapter 10 of the New Jersey Business Corporations Act, the *AGREEMENT AND PLAN OF MERGER OF BIOLINE USA INC., A NEW JERSEY CORPORATION INTO BIOLINE USA INC., A MASSACHUSETTS CORPORATION*. (a copy of which is attached hereto) has been duly adopted and approved by the unanimous written consent of the sole shareholder of each of the Merging Corporations, respectively. As to each of the Merging Corporations, such unanimous written consent was given by the sole shareholder of all of the outstanding shares of such corporation on March 15, 2002. The corporation surviving this merger is BIOLINE USA INC., a Massachusetts corporation, and no change is being made at this time to the name of such surviving corporation.

The laws of the Commonwealth of Massachusetts, the jurisdiction of organization of BIOLINE USA INC., a Massachusetts corporation (the surviving corporation) permit the merger contemplated by the Plan of Merger, and the laws of the Commonwealth of Massachusetts upon fulfillment of all filing and recording requirements set forth in the applicable laws of the Commonwealth of Massachusetts will have been complied with.

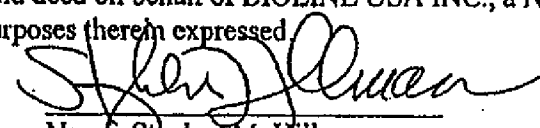

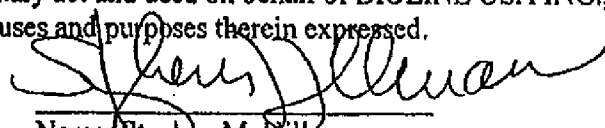
