CONFIRMATORY ASSIGNMENT

WHEREAS, Schraff's Ice Cream Company, Ltd., a corporation organized under the laws of the State of Delaware, having a place of business at 2000 Richmond Terrace, Staten Island, New York, 10302 (hereinafter "Assignor") was the owner of all right, title and interest in and to the trademarks listed in the attached Schedule A (the "Trademarks");

WHEREAS, 41 License Corp., a corporation organized under the laws of the State of New York, having a place of business at 4175 Veterans Highway Ronkonkoma, New York, 11779 (hereinafter "Assignee"), was to have acquired the Trademarks by assignment through an Assignment, which included multiple trademarks, and was meant to include the Trademarks, executed on July 25, 1995 (the "July 25, 1995 Assignment");

WHEREAS, Assignee did acquire all right, title and interest to those trademarks listed in the July 25, 1995 Assignment;

WHEREAS, the Trademarks were inadvertently excluded from the July 25, 1995 Assignment, however, Assignee did acquire all right, title and interest to the Trademarks on July 25, 1995;

WHEREAS the parties are desirous of memorializing the transfer of all legal right, title and interest in and to the Trademarks together with the goodwill appurtenant thereto, the business associated therewith and any and all past and present rights which have accrued to Assignor incidental or appertaining to the Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor confirms the assignment to Assignee, effective as of July 25, 1995, of all of its right, title and interest in and to the Trademarks, together with the

goodwill of the business appurtenant to and symbolized by the Trademarks and the right to sue and recover for, and the right to profits or damages due or accrued arising out of or in connection with, any and all past, present or future infringements or dilution of or damage or injury to the Trademarks, to be held and enjoyed by Assignee, its successors and assigns to the same extent that such would have been held and enjoyed by Assignor had such assignment not been made.
