**ASSIGNMENT OF TRADEMARK**

WHEREAS, Unifix Inc., a Canadian corporation ("Assignor"), is the owner of U.S. Serial No. 75/403,701, which matured into U.S. Registration No. 2,373,391, for the mark EDGETECH in connection with concrete panels (the "Trademark"), together with the goodwill symbolized thereby;

WHEREAS, New NGC, Inc., a Delaware corporation ("Assignee"), is desirous of acquiring the Trademark, together with the goodwill symbolized thereby; and,

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Assignor hereby assigns *nunc pro tunc* as of December 15, 1998, to Assignee all its right, title and interest in and to the Trademark, together with the goodwill of the business associated with or symbolized by the Trademark, and any and all common law rights, world-wide rights and other applications or registrations for such Trademark owned by Assignor, and including the right to sue and collect damages for any past or future infringements of the Trademark. Assignee is a successor to the business of Assignor, or portion thereof, to which the Trademark pertains, and such business is ongoing and existing.
  
2. Assignor shall execute and deliver or shall cause to be executed and delivered all such transfers, assignments, conveyances, powers of attorney, assurances or any other documents necessary to confirm, effectuate or record the assignment granted herein and shall take all such further action, including, without limitation, making all filings with the United States Patent & Trademark Office in order to confirm, effectuate or record this assignment of the Trademark to Assignee granted herein as Assignee may from time to time reasonably request.

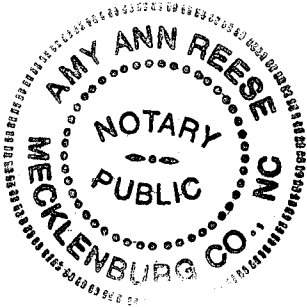
