RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "**Release**") is made as of December 23, 2005 (the "**Effective Date**") between AMSCAN INC., a New York corporation, AM-SOURCE, LLC, a Rhode Island limited liability company, ANAGRAM INTERNATIONAL, INC., a Minnesota corporation, M&D INDUSTRIES, INC, a Delaware corporation, and TRISAR, INC., a California corporation (each a "**Grantor**" and together the "**Grantors**") and GENERAL ELECTRIC CAPITAL CORPORATION, a New York corporation, as collateral agent (in such capacity, the "**Collateral Agent**") for the Secured Parties.

WHEREAS, pursuant to the terms and conditions of that certain Pledge and Security Agreement, dated as of April 30, 2004 between the Grantors and the Collateral Agent (the "**Security Agreement**"; all capitalized terms used but not defined herein shall have the respective meanings ascribed thereto in the Security Agreement), the Grantors granted to the Collateral Agent a continuing security interest in all of their right, title and interest in and to the trademarks, including without limitation the trademark registrations and applications set forth on Schedule I hereto (collectively, the "**Trademarks**"), together with the goodwill associated therewith;

WHEREAS, the Security Agreement relating to the Trademarks was recorded with the Trademarks Division of the U.S. Patent & Trademark Office on May 13, 2004 at Reel 2968 and Frames 0187, 0240, 0062, 0021, and 0110.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby terminates the Security Agreement, and hereby terminates, cancels, re-pledges, reassigns and releases any and all security interests it has against the Trademarks together with the goodwill associated therewith, without warranty or recourse.

If and to the extent the Collateral Agent has acquired any right, title or interest to any of the Trademarks, it hereby assigns and transfers such rights, title or interest to the Grantors.

The Collateral Agent shall take all further actions, and provide to the Grantors and each of their respective successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), requested by the Grantors to more fully and effectively effectuate the purposes of this Release.
