**RELEASE OF COLLATERAL PATENT,
TRADEMARK, COPYRIGHT AND LICENSE ASSIGNMENT**

BE IT KNOWN THAT:

WHEREAS, to secure payment of its obligations under that certain Credit Agreement dated as of December 1, 1985 (the "1985 Credit Agreement"), made by FEDERAL CARTRIDGE CORPORATION (now a part of Federal Hoffman, Inc.) (the "1985 Assignor"), with FIRST NATIONAL BANK OF MINNEAPOLIS (now U.S. BANK NATIONAL ASSOCIATION) ("U.S. Bank"), and THE FIRST NATIONAL BANK OF BOSTON (now part of BANK OF AMERICA, N.A) ("BoA" and collectively with U.S. Bank, the "1985 Assignees"), the 1985 Assignor pledged to U.S. Bank as the administrative agent for the 1985 Assignees certain intellectual property assets including the patents and patent applications, trademark registrations and trademark applications, and copyrights all as set forth on Schedule A to that certain Collateral Patent, Trademark, Copyright and License Assignment dated December 1, 1985 by and between the 1985 Assignor and the 1985 Assignees (the "1985 Collateral Assignment") which was recorded as follows:

in the Patent Records of the United States Patent and Trademark Office on December 23, 1985 in Reel/Frame Nos. 004489/0975-0990; and

in the Trademark Records of the United States Patent and Trademark Office on December 23, 1985 in Reel/Frame Nos. 0515/851-866.

WHEREAS, to secure payment of its obligations under that certain Credit Agreement dated as of July 1, 1988 (the "1988 Credit Agreement") made by FEDERAL-HOFFMAN, INC. (the successor by merger of FC ACQUISITION, INC. and FEDERAL CARTRIDGE CORPORATION) (the "1988 Assignor"), with FIRST BANK NATIONAL ASSOCIATION (formerly known as FIRST NATIONAL BANK OF MINNEAPOLIS, now U.S. BANK NATIONAL ASSOCIATION), and THE FIRST NATIONAL BANK OF BOSTON (now part of BANK OF AMERICA, N.A) ("BoA" and collectively with U.S. Bank, the "1988 Assignees"), the 1988 Assignor pledged to U.S. Bank as the administrative agent for the 1988 Assignees certain assets including the patents and patent applications, trademark registrations and trademark applications, and copyrights all as set forth on Schedule A to that certain Collateral Patent, Trademark, Copyright and License Assignment dated July 1, 1988 by and between the 1988 Assignor and the 1988 Assignees (the "1988 Collateral Assignment") which was recorded as follows:

in the Patent Records of the United States Patent and Trademark Office on September 26, 1988 in Reel/Frame Nos. 004948/204-215; and

in the Trademark Records of the United States Patent and Trademark Office on September 26, 1988 in Reel/Frame Nos. 0635/352-363.

WHEREAS, the 1985 Assignor obligations under the 1985 Credit Agreement have been fully paid and discharged.

WHEREAS, the 1988 Assignor obligations under the 1988 Credit Agreement have been fully paid and discharged.

WHEREAS, to terminate and release the security interest rights granted under the 1988 Credit Agreement the 1988 Assignees executed a Patent, Trademark, Copyright and License Assignment dated July 18, 1990 from the 1988 Assignees to the 1988 Assignor (the "1990 Collateral Assignment") which was recorded as follows: in the Patent Records of the United States Patent and Trademark Office on January 18, 1991 in Reel/Frame Nos. 5581/069-079.

WHEREAS, the parties desire to clear up and to release all rights granted under the 1985 Collateral Assignment and the 1988 Collateral Assignment, including Assignors' security interest in patent applications, trademark registrations and trademark applications, and the copyrights and other intellectual property, all as set forth on the schedules to those Collateral Assignments or otherwise identified as collateral in such Collateral Assignments.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, U.S. BANK NATIONAL ASSOCIATION, as administrative agent on behalf of itself and the 1985 Assignees and 1988 Assignees, does hereby release, satisfy, terminate and discharge the pledge to the 1985 Assignees and 1988 Assignees of, and its security interest in,



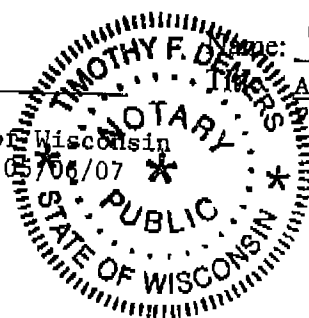


(c) all other copyright rights and other intellectual property rights covered by the identification of Collateral in the 1985 Collateral Assignment and 1988 Collateral Assignment.
