The foregoing amendment was adopted by the corporation's board of directors acting by unanimous written consent on July 18, 2001

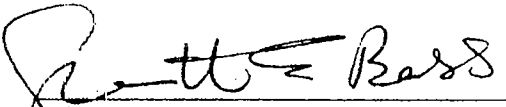
FOUR
