**Deed of ASSIGNMENT**

**THIS DEED of ASSIGNMENT** is made the 9<sup>th</sup> day of November 2005

**BETWEEN**

**Filtrona Suisse, S.A.**, a company organised and existing under the laws of **Switzerland**, and of Route de Bussigny 31, CH-1023 Crissier, Switzerland  
(hereinafter referred to as "the Assignor")

**AND**

**Filtrona International Limited**, a company organised and existing under the laws of **United Kingdom**, and of Avebury House, 201-249 Avebury Boulevard, Milton Keynes, MK9 1AU (hereinafter referred to as the Assignee")

**WHEREAS**

- A. The Assignor is the proprietor of a number of trade mark registrations and applications filed to register their marks, listed in the schedule hereto (hereinafter referred to as "the Trade Marks");
- B. It has been agreed, for the purposes of internal reorganisation between related companies, that the Trade Marks are to be assigned to the Assignee upon the terms hereinafter appearing.

**NOW THIS DEED WITNESSETH AS FOLLOWS:**

1. The Assignor hereby ASSIGNS unto the Assignee all the property, right, title and interest in and to the Trade Marks, together with the goodwill in the Trade Marks TO HOLD unto the Assignee absolutely and free from all licences, charges or other encumbrances **TOGETHER WITH** all rights of action, powers and benefits arising or accrued in relation thereto including, without limitation, the right to take or continue proceedings, including trade mark opposition proceedings, and to seek and recover damages and seek other remedies for all past infringements thereof.



2. The Assignee hereby accepts the assignment of all rights hereby transferred.


