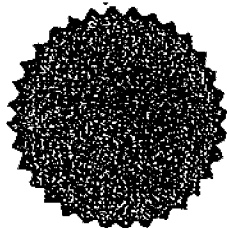

Pursuant to the provisions of Sections 242, 229 and 141 of the Delaware Corporation Law, the undersigned corporation executes the following Certificate of Amendment to its Certificate of Incorporation:

1. The name of the corporation is Community Corrections Corporation (the "Corporation").
2. The Certificate of Incorporation of the Corporation was originally filed with the Secretary of State of the State of Delaware on July 26, 1996 and was amended and restated in its entirety on August 10, 2001.
3. The following further amendment to the Corporation's Certificate of Incorporation was declared advisable and duly adopted by the Corporation's Board of Directors and approved by the shareholders of the Corporation entitled to vote.

RESOLVED, that the Corporation's Certificate of Incorporation be amended as follows:


ARTICLE FIRST of the Certificate of Incorporation shall be amended in its entirety to read as follows:
