RELEASE OF SECURITY INTEREST  
IN TRADEMARKS

For good and valuable consideration, receipt of which is hereby acknowledged, Agent hereby releases, retransfers and reassigns to Grantors, without representation or warranty of any kind, express or implied, all of Agent's and Lenders' right, title and interest in and to the Released Marks and the goodwill associated therewith.


