**ASSIGNMENT**

THIS ASSIGNMENT, effective as of the date shown below, is from Pace International, LLC, a Washington limited liability company ("Assignor"), to CJB Industries, Inc., a Georgia corporation ("Assignee").

**RECITALS**

WHEREAS, Assignor desires to assign to Assignee all right, title and interest in and to the trademark ACTIVATE (the "Mark") and the related United States trademark registration, U.S. Reg. No. 0821821, together with any and all goodwill of the business associated with the Mark; and

WHEREAS, Assignee desires to acquire the Mark and all goodwill of the business associated therewith from Assignor; and

WHEREAS, Assignor and Assignee desire to confirm of record the assignment of the Mark to Assignee;

NOW, THEREFORE, for \$250.00 and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee hereby agree as follows:

1. Assignor hereby assigns to Assignee all right, title and interest in and to the Mark, together with (i) the goodwill of the business symbolized by the Mark and (ii) all causes of action, claims and demands and other rights for, or arising from, any infringement, including past infringements, of the Mark.

2. Assignor further agrees without additional consideration but at no out-of-pocket cost to Assignor, to cause to be performed such other lawful acts and to be executed such further assignments and other lawful documents as Assignee may from time to time reasonably request to effect fully this Assignment and to permit Assignee to be duly recorded as the registered owner of the Mark and all other rights hereby conveyed.
