I, Regis J. Hebbeler, hereby declare as follows:

1. The Assignment document signed by myself as Senior Vice President of Goody's Family Clothing, Inc., and dated July 29, 2005, and recorded on August 1, 2005, at Reel/Frame 3131/0907, erroneously included U.S. Registration No. 2,230,045.

2. By a prior assignment dated January 2, 2001, and recorded on January 8, 2001, at Reel/Frame 2217/0551, Goody's Family Clothing, Inc. assigned U.S. Registration No. 2,230,045 to Sydoog, Inc. The remaining transfers of the assignment are believed to be correct.


3. U.S. Registration No. 2,230,045 was subsequently assigned by Sydoog, Inc. to Sydoog, LLC by virtue of the assignment recorded on August 1, 2005, at Reel/Frame 3131/0769. Both Sydoog, Inc. and Sydoog, LLC are wholly owned subsidiaries of

Registration No. 2, 230,045  
Goody's Family Clothing, Inc. Accordingly, the record owner of U.S. Registration No. 2,230,045 should be Sydoog, LLC.
