DEED OF ASSIGNMENT



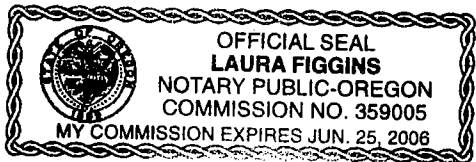


