TRADEMARK ASSIGNMENT

This **TRADEMARK ASSIGNMENT** ("Assignment") is effective as of November 10, 2005 (the "Effective Date") by and between ELKAY MANUFACTURING COMPANY ("Assignor"), an Illinois corporation, having its principal place of business at 2222 Camden Court, Oak Brook, Illinois 60523, and MEDALLION CABINETRY, INC. ("Assignee"), a Minnesota corporation, having its principal place of business at 180 Industrial Boulevard, Waconia, Minnesota 55387.

WHEREAS, Assignor owns all right, title and interest in and to the trademark MEDALLION (the "Mark") in connection with the following goods and/or services: kitchen cabinets, bath and vanity cabinets and related accessories, namely appliance end panels, appliance front panels, and appliance garages, all for cabinets; bookcases, cutlery dividers for drawers, drawers, hampers, non-metal hinges, plastic and wood knobs, medicine cabinets and mirrors; metal hinges, knobs, and metal door toe kick plates, all for kitchen and bath; electric lighting fixtures for kitchen and bath, and range hoods; wood molding and wood soffit components, namely moldings and panels, all for kitchen and bath; and knife boards, cookbook racks, porcelain knobs, lazy susans, spice racks, towel bars, waste baskets, wine glass holders and wine racks, all for kitchen and bath; and

WHEREAS, Assignor owns a federal registration for the Mark on the Principal Register of the United States Patent and Trademark Office in connection with the goods and/or services identified therein, Registration No. 1,964,983, registered on April 2, 1996; and

WHEREAS, Assignor wishes to assign to Assignee, and Assignee wishes to acquire from Assignor, all of Assignor's right, title and interest in and to the Mark.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby sells, assigns and transfers to Assignee, all right, title and interest in the United States of America, its territories and possessions, and in all foreign countries, in and to the Mark and all common law rights therein together with the goodwill of the business symbolized by the Mark, and the registration thereof. Assignor represents and warrants that he has not previously assigned or licensed the Mark or any rights therein except to Assignee.



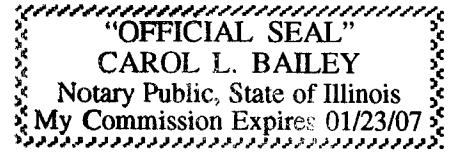


