Pursuant to the provisions of Section 351.095.2 of The General and Business Corporation Law of Missouri, the undersigned corporation certifies the following:

1. The present name of the corporation is ILC Acquisition Company. The name under which the corporation was originally organized was ILC Acquisition Company.
2. An amendment to the corporation's Articles of Incorporation was adopted by the corporation's shareholder on June 28, 2005.
3. Article One of the corporation's Articles of Incorporation is amended to read as follows:

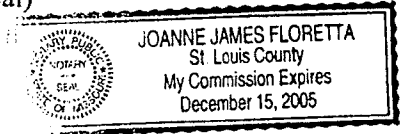

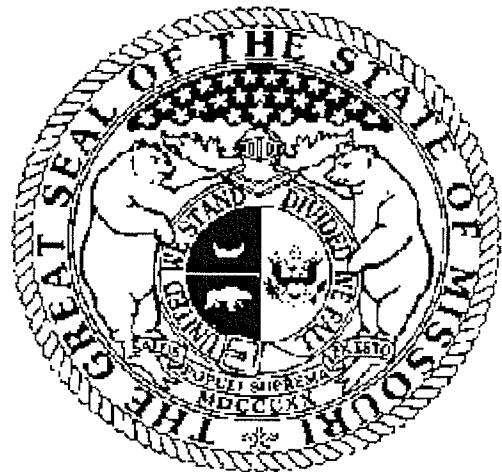
