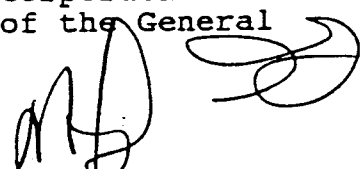
It is hereby certified that:

The names of the constituent business corporations participating in the merger herein certified are Reynolds International, Inc., which is a business corporation organized under the laws of the State of Texas ("Reynolds"), Rome Plow Company, a business corporation organized under the laws of the State of Georgia ("Rome Plow"), Inter-American Transport Equipment Co., a business corporation organized under the laws of the State of Florida ("Transport Equipment"), and Inter-American Vanguard Corp., a business corporation organized under the laws of the State of Delaware ("Vanguard").

4. The Certificate of Incorporation of Inter-American Vanguard Corp., as now in force and effect, shall continue to be the Certificate of Incorporation of said surviving corporation until amended and changed pursuant to the provisions of the General Corporation Law of the State of Delaware.

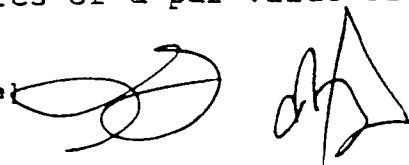

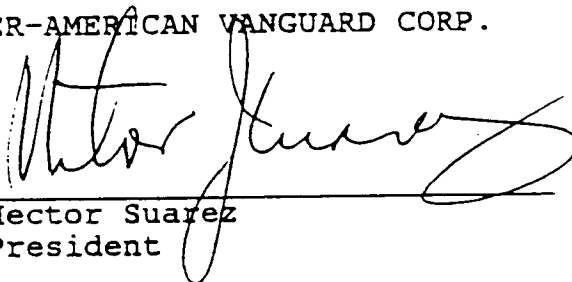
