Assignor hereby requests the Commissioner of Patents and Trademarks to record Assignee as the assignee and owner of the Mark.

Assignor shall execute or arrange for execution of such further assignment documents as may be required to permit Assignee to obtain recording of the assignment to Assignee of the Mark.
