

FIRST: That the board of directors of said corporation, at a meeting duly called and held on March 21, 1988, adopted a resolution proposing and declaring advisable the following amendment to the Certificate of Incorporation of said corporation:

RESOLVED, that the board of directors proposes, and declares the advisability of, an amendment to the Restated Certificate of Incorporation deleting ARTICLE FIRST and inserting the following new ARTICLE FIRST:
