ASSIGNMENT OF TRADEMARK


WHEREAS, RICHARD W. GOOD, an adult individual with an address of 275 Edgemere Drive, Lancaster, Pennsylvania 17601 ("Assignor"), is the owner of the entire right, title and interest in and to the GOOD'S FURNITURE stylized trademark (the "Trademark") for retail outlets featuring home furnishings, and United States Registration No. 2,363,459, and all goodwill associated with the Trademark; and

WHEREAS, RICHARD'S FLOOR COVERING, INC., a Pennsylvania corporation with an address of 197D Greenfield Road, Lancaster, Pennsylvania 17601 ("Assignee"), is desirous of acquiring the Trademark and the registration thereof, together with the goodwill of the business associated with the Trademark.

NOW, THEREFORE, in consideration of and in exchange for the sum of One Dollar (\$1.00) and other good and valuable consideration, receipt and sufficiency of which are hereby acknowledged by Assignor, Assignor, intending to be legally bound, does hereby assign unto Assignee, all of Assignor's right, title and interest in and to the Trademark and its registration, together with the goodwill of the business associated with the Trademark.

Assignor represents and warrants to Assignee that Assignor has not sold, transferred or assigned the Trademark to any other person or entity and that the Trademark is being transferred and assigned by Assignor to Assignee free and clear of any charge, claim, equitable interest, lien, option, pledge, security interest or right of first refusal, restriction, covenant, license or other encumbrance.
