TRADEMARK ASSIGNMENT

This Trademark Assignment made this 23RD day of AUGUST, 2005, is by Voyage Telecom, Inc. in favor of Contigo Cellular, LLC.

WITNESSETH

WHEREAS, Voyage Telecom, Inc., a New Jersey corporation having a principal address of 11508H Providence Road, Suite 201, Charlotte, NC 28277 (hereinafter referred to as "Assignor") is the owner of:

- (a) United States Trademark Reg. No. 2,355,940, for the mark AZTECA in International Class 16 for prepaid telephone calling cards not magnetically encoded;
- (b) United States Trademark Reg. No. 2,511,167 for the mark AZTECA CELLULAR in International Class 9 for cellular phones; and
- (c) United States Trademark Reg. No. 2,355,939, for the mark AZTECA TARJETA TELEFONICA in International Class 16 for prepaid telephone calling cards not magnetically encoded.

WHEREAS, Assignor is desirous of assigning to Contigo Cellular, LLC, a Delaware limited liability company having a principal address of 12716 Woodward, Overland Park, KS 66213 (hereinafter referred to as "Assignee") the Marks and Assignee is desirous of acquiring all rights in and to the Marks including any and all common law rights in and to the Marks, pursuant to the terms and conditions of that certain Assignment of Intellectual Property Rights Agreement dated Aug. 1, 2005 by and between Assignor and Assignee (hereinafter referred to as the "Agreement").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, subject to the terms and conditions of the Agreement, Assignor hereby assigns to Assignee, all right, title and interest throughout the world in and to the Marks, together with all the goodwill associated therewith.
