- (8) The authorized capital stock of Roving-MA is 26,104,194 shares, consisting of 17,000,000 shares of Common Stock, no par value; 2,330,000 shares of Series A Redeemable Convertible Preferred Stock, no par value; and 6,774,194 shares of Series B Convertible Preferred Stock, no par value.
