TERMINATION OF COLLATERAL ASSIGNMENT AND SECURITY AGREEMENT
(TRADEMARKS AND TRADEMARK LICENSES)

THIS TERMINATION OF COLLATERAL ASSIGNMENT is made and executed as of August 23, 2005, by American AgCredit, PCA, successor in interest to Pacific Coast Farm Credit Services, ACA ("Lender")

RECITALS

- A. De Lorimier Winery, a California corporation now known as Mosaic Vineyards & Winery, Inc. ("Borrower") delivered to Lender that certain Collateral Assignment and Security Agreement (Trademarks and Trademark Licenses) as of November 14, 1997 (the "Collateral Assignment") that granted Lender a security interest in the trademarks listed below (the "Trademarks") and assigned the Trademarks to Lender to secure a commercial loan (the "Loan").

- B. The Collateral Assignment was recorded with the United States Patent and Trademark Office on December 22, 1997 as Document Number 100600317A in Reel 1670, Frame 0669.
- C. Borrower has paid the Loan in full and is entitled to termination of the Collateral Assignment. However, collateral assignments may not be "released" on the records of the United States Patent and Trademark Office; rather, they may only be "re-assigned". Borrower has requested in writing that the Trademarks previously assigned to Lender be re-assigned to Alfred A. de Lorimier and Sandra M. de Lorimier, as Trustees of the U.D. Trust (the "Trust").
- D. Lender is providing this Termination of Collateral Assignment to fully and completely release its security interest in the Trademarks created by the Collateral Assignment and to re-assign said Trademarks to the Trust.

NOW, THEREFORE, Lender hereby absolutely and irrevocably assigns the Trademarks to the Trust, without recourse, representation or warranty.
