TRADEMARK ASSIGNMENT

Assignor agrees to take all lawful acts that Assignee may deem advisable or necessary in order to render this Assignment fully effective, to carry out the intent of this instrument and to register, record and enforce the rights conveyed hereby, including without limitation, execution of lawful documents, and cooperation in production of evidence and giving of testimony in connection with proceedings to enforce the rights conveyed hereby.

This Assignment may be executed in counterparts, all of which together shall constitute one and the same instrument.
