Cephalon, Inc., a corporation incorporated on the 24th day of August, 1987, pursuant to the provisions of the General Corporation Law of the State of Delaware (the "Company");

DOES HEREBY CERTIFY that the Company owns all of the capital stock of Salmedix, Inc., a corporation incorporated on the 28th day of November, 2000, pursuant to the provisions of the General Corporation Law of the State of Delaware ("Salmedix"), and that the Company, by a resolution of its Board of Directors duly adopted at a meeting held on the 1st day of December, 2005, determined to merge into itself said Salmedix, which resolution is in the following words to wit:

WHEREAS, Cephalon, Inc. (the "Company") owns 100% of the outstanding stock of Salmedix, Inc., a corporation organized and existing under the laws of Delaware ("Salmedix"), and

WHEREAS, the Company desires to merge Salmedix into itself, and to thereafter be possessed of all the estate, property, rights, privileges and franchises of Salmedix,

NOW, THEREFORE, BE IT RESOLVED, that the Company merge Salmedix into itself and assume all of the liabilities and obligations of Salmedix pursuant to said merger; and

FURTHER RESOLVED, that the officers of the Company be, and each officer singly hereby is, directed to make and execute a certificate of ownership setting forth a copy of the resolution to merge Salmedix and assume its liabilities and obligations, and the date of adoption thereof, and to file the same in the office of the Secretary of the State of Delaware; and

FURTHER RESOLVED, that the officers of Cephalon be and they hereby are authorized and directed to do all acts and things whatsoever, whether within or without the State of Delaware which may be in any way necessary or proper to effect said merger.
