RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, Wambold Corporation, a Delaware corporation, with an address at Suite 202, 103 Foulk Road, Wilmington, DE 19803 (the "Grantor") executed a Trademark Security Agreement dated April ____, 2002, which was recorded in the U.S. Patent and Trademark Office on April 30, 2002 at Reel 2494, Frame 0885 (hereinafter the "Grant"), to Antares Capital Corporation, as Agent (hereinafter the "Bank");

WHEREAS, the Grant grants to the Bank a security interest in certain trademarks ("Trademarks") as more particularly described therein and as hereinafter set forth, the goodwill of the business symbolized by said Trademarks and Applications and any and all license agreements relating thereto, in order to secure the payment and performance of certain obligations (hereinafter the "Obligations") of Grantor to Bank, and Bank still holds such security interest; and

WHEREAS, Grantor has satisfied the Obligations, and Bank's security interest is being terminated and cancelled concurrently herewith;

NOW, THEREFORE, in consideration of the foregoing premises, and the satisfaction of the Obligations, Bank hereby releases Grantor and all its successors in interest from any and all interest Bank now has or which it may have with respect to the right, title and interest in and to the subject Trademarks (including, without limitation, the Trademarks set forth on Exhibit A attached hereto), the goodwill of the business symbolized by said Trademarks and any and all license agreements relating thereto, and all other rights and interests set forth in the Grant.
