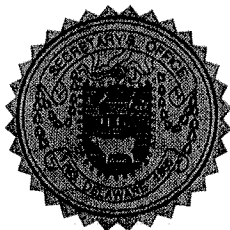

SECOND The Corporation's Amended Certificate of Incorporation, is hereby amended by amending Article I thereof to read in its entirety as follows:

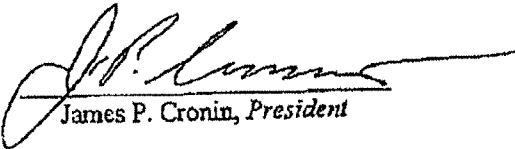
1. The name of the corporation is **Cytec Surface Specialties Inc.**
