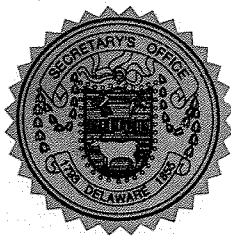

“The name of the corporation is Parago Promotional Services, Inc.”

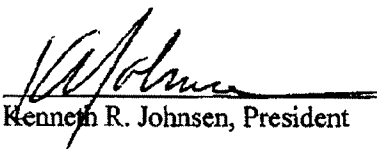
**ARTICLE III**
