**NOW, THEREFORE**, in consideration of Assignee's payment of \$5,000 U.S. and other good and valuable consideration, and in connection with a concomitant assignment of any remaining goodwill of the Assignor's past business connected with the use of and symbolized by the marks, the sufficiency and receipt of which is hereby acknowledged, the Assignor does hereby sell, assign, transfer and convey unto the Assignee any interest in and to the marks and in and to all trademark rights related to the marks it may have associated with its past business under the marks, which rights may include but are not necessarily limited to all rights to any and all U.S. and foreign trademarks, tradenames, service marks, and all ancillary rights related to the marks, any and all similar such names and derivations thereof, and any and all copyrights, abridgment rights, publicity and moral rights and all other intellectual property rights related to the marks, in the United States, Russia, and worldwide, and all rights Assignor may have in the design shown in Exhibit 1, and the stylized depictions of the text mark DEEP SEA shown in Exhibit 2. This assignment is given "AS IS." The Assignor makes no warranty as to its rights, if any, in the marks or associated goodwill, if any, and expressly retains all right title and interest in all other trademarks and tradenames associated with its past and present business.

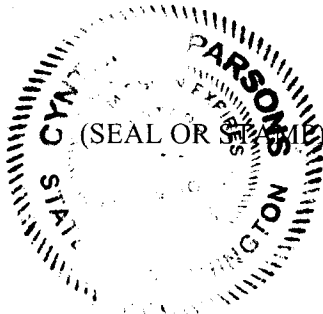
