

**THIS RELEASE**, granted on this 25<sup>th</sup> day of August, 2005, is delivered by ROYAL BANK OF CANADA (the "**Bank**") having its head office at 1 Place Ville-Marie, Montreal, Province of Quebec, under Deed of Movable Hypothec referred to below.
