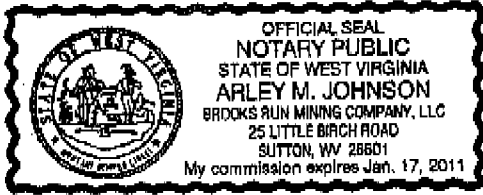

No destination for Spring Run has been made yet.


Next council meeting April 17th at Mountain Chapter ramp fest.
