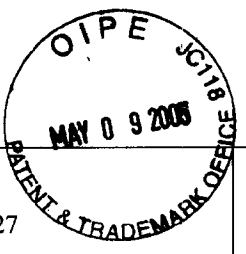

GRANT OF SECURITY INTEREST

WHEREAS, MOHAWK PAPER MILLS, INC., a New York corporation (herein referred to as "Debtor"), owns all right, title and interest in and to the U.S. trademarks listed on the annexed Schedule A (the "Trademarks");
