ASSIGNMENT OF TRADEMARKS

3. Assignor agrees that it will, upon reasonable request, and without further consideration, do such things and execute such further documents as are reasonably necessary to vest title thereto in Assignee, its successors, assigns and legal representatives or nominees, and to enforce such rights.

This Assignment shall be supplemented by that certain Asset Purchase Agreement, dated as of the date hereof, by and among Assignor, Assignee, Tepro Financial Services, Inc., an Ontario corporation, and Joerg Stieber and Michael Stieber with respect to matters as to which this Assignment may be silent.

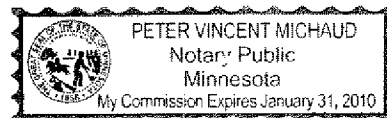
