

INTELLECTUAL PROPERTY SECURITY AGREEMENT RELEASE

This INTELLECTUAL PROPERTY SECURITY AGREEMENT RELEASE (this "*Release*") is made as of August 8, 2005, (the "*Effective Date*"), by Bank of America, N.A. ("*Bank of America*"), as Collateral Agent for each of the Secured Parties (as defined in the Credit Agreement referred to below), in favor of Encore Medical Asset Corporation.

WHEREAS, pursuant to (i) that certain Credit Agreement dated as of October 4, 2004, (as amended, amended and restated, supplemented or otherwise modified from time to time, the "*Credit Agreement*"), by and among Encore Medical Corporation, Encore Medical IHC, Inc., Bank of America, as Administrative Agent, Swing Line Lender and L/C Issuer and the Lenders party thereto, and (ii) that certain Intellectual Property Security Agreement dated as of October 4, 2004, between the Grantors (as defined in the Credit Agreement) and Bank of America, as Collateral Agent (the "*Collateral Agent*") (as amended, amended and restated, supplemented or otherwise modified from time to time, the "*Security Agreement*"), each Grantor has granted to the Collateral Agent, a security interest in, among other property, certain intellectual property of the Grantors (terms defined in the Credit Agreement and not otherwise defined herein are used herein as defined in the Credit Agreement);

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office with respect to registered patents and trademarks; and

WHEREAS, in accordance with the provisions of the Credit Agreement and the Security Agreement, the Collateral Agent desires to release its security interest in and to the patents and trademarks identified on Schedule A attached hereto (the "*Released Intellectual Property*").


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agree as follows:

1. The Collateral Agent, hereby releases to Encore Medical Asset Corporation the security interest in, to and under the Released Intellectual Property granted pursuant to the Security Agreement.
2. This Release may be executed in one or more counterparts, each of which when executed shall be deemed an original but all of which taken together shall constitute one and the same agreement. Copies of executed counterparts transmitted by telecopier or other electronic transmission service shall be effective as delivery of an original executed counterpart of this Release.
3. This Release shall be governed by, and construed in accordance with, the laws of the State of New York.
