RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Release") is made as of November 22, 2005 (the "Effective Date") among ACCELLENT CORP., formerly known as among MEDICAL DEVICE MANUFACTURING, INC. (the "Company"), each Subsidiary of the Company listed on Schedule I hereto (the "Subsidiary Grantors" and, together with the Company, the "Grantors") and Credit Suisse First Boston, acting through its Cayman Islands Branch, (in such capacity, the "Collateral Agent"), for the benefit of the Secured Parties (as defined in the Security Agreement).

WHEREAS, pursuant to the terms and conditions of that certain Pledge and Security Agreement, dated as of June 30, 2004, between the Grantors and the Collateral Agent (the "Security Agreement"), the Grantors pledged, assigned and granted to the Collateral Agent a continuing security interest in all of its right, title and interest in and to the Collateral (as defined in the Security Agreement), including without limitation the trademark registrations and applications set forth on Schedule II hereto (collectively, the "Trademarks"), together with the goodwill associated therewith;

WHEREAS, the Security Agreement relating to the Trademarks was recorded with the Trademarks Division of the U.S. Patent & Trademark Office on August 13, 2004 at Reel 2926 and Frame 0667, 0720, 0706, 0742, 0714, 0772, 0736, 0704, 0748, 0766, 0729, 0754;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby terminates the Security Agreement, and hereby terminates, cancels, re-pledges, reassigns and releases any and all security interests it has against the Collateral, without warranty or recourse.

If and to the extent the Collateral Agent has acquired any right, title or interest to any of the Collateral, it hereby assigns and transfers such rights, title or interest to the Grantors.

The Collateral Agent shall take all further actions, and provide to the Grantors and each of its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), requested by the Grantors to more fully and effectively effectuate the purposes of this Release.
