

SUPPLEMENT TO SECURITY AGREEMENT (TRADEMARKS)

WHEREAS, Almatris, Inc., a Delaware corporation (herein referred to as "**Grantor**"), having an address at 501 West Park Road, Leetsdale Pennsylvania 15056 (1) has adopted, used and is using, or (2) has intended to use and filed an application indicating that intention, but has not yet filed an allegation of use under Section 1(c) or 1(d) of the Trademark Act, or (3) has filed an application based on an intention to use and has since used and has filed an allegation of use under Section 1(c) or 1(d) of the Trademark Act, the trademarks, trade names, trade styles and service marks listed on the annexed Schedule I-A, which trademarks, trade names, trade styles and service marks are registered in the United States Patent and Trademark Office (the "**Trademarks**"); and

WHEREAS, Grantor has entered into a Security Agreement dated as of December 21, 2005 (said Security Agreement, as it may hereafter be amended or otherwise modified from time to time being the "**Security Agreement**", the terms defined therein and not otherwise defined herein being used herein as therein defined) in favor of Secured Party; and
