AMENDED AND RESTATED TRADEMARK ASSIGNMENT OF SECURITY

WHEREAS, Everlast World's Boxing Headquarters Corporation, a corporation organized under the laws of the State of New York, located at 1350 Broadway, NY, NY 10018 (the "Company"), has adopted, used and is using the marks shown in the attached Schedule A (the "Marks"), for which there are registrations and/or applications in the United States Patent and Trademark Office under the numbers shown in the attached Schedule A; and

WHEREAS, Company is obligated to WELLS FARGO CENTURY, INC. ("Secured Party") pursuant to (i) that certain Trademark Collateral Security Agreement, dated June 8, 2005 by Company in favor of Secured Party (the "Original Trademark Security Agreement"), and (ii) that certain Amended and Restated Trademark Collateral Security Agreement, dated the date hereof, by Company and the other Debtors signatory thereto in favor of Secured Party, which amends and restates the Original Trademark Security Agreement in its entirety in order to expand the obligations secured thereunder and add additional Marks as security therefor (as may be amended, modified, restated or supplemented from time to time, the "Agreement"); and

WHEREAS, pursuant to the Agreement, Company is granting to Secured Party a security interest in the Marks, the goodwill of the business symbolized by the Marks, and the registrations and applications therefor.


NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Company does hereby assign unto Secured Party and grant to Secured Party a security interest in and to the Marks, together with the goodwill of the business symbolized by the Marks, and registrations and applications therefor, which assignment and security interest shall secure all the Obligations as defined in the Agreement and in accordance with the terms and provisions thereof. Nothing in the Amended and Restated Trademark Assignment of Security shall be deemed to release the security interest granted to Secured Party with respect to any of the Marks pursuant to the Original Trademark Security Agreement.


Company expressly acknowledges and affirms that the rights and remedies of Secured Party with respect to the assignment and security interest granted hereby are more fully set forth in the Agreement.


