**RELEASE OF SECURITY INTEREST IN  
INTELLECTUAL PROPERTY COLLATERAL**

This RELEASE, dated as of February 2, 2006, is made by Deutsche Bank Trust Company Americas, a New York banking corporation, as Collateral Agent ("Deutsche Bank"), pursuant to the termination of the Intellectual Property Security Agreement (the "Security Agreement"), by and among, Deutsche Bank and NRG Energy, Inc. a Delaware corporation and related entities ("NRG Energy").

**WITNESSETH**

WHEREAS, pursuant to the Security Agreement dated December 23, 2003, and recorded with the U.S. Patent and Trademark Office on January 5, 2004 at Reel/Frame No. 2772/0450, NRG Energy granted Deutsche Bank a security interest in all Collateral constituting Intellectual Property (as such terms are defined in the Security Agreement);

WHEREAS, Deutsche Bank acknowledges the full payment, complete performance and satisfaction of all obligations pursuant to the Security Agreement;

WHEREAS, NRG Energy has requested that Deutsche Bank release its security interest in the Collateral constituting Intellectual Property (as such terms are defined in the Security Agreement) (the "Released Collateral").

NOW, THEREFORE, in consideration of the foregoing, Deutsche Bank hereby releases, relinquishes and discharges, without recourse, all of its security interest and re-assigns any right, title or interest it may have in the Collateral constituting Intellectual Property (as such terms are defined in the Security Agreement), including the trademark registrations listed on Schedule A attached hereto and incorporated herein by reference and all goodwill associated therewith and the goodwill of the business symbolized thereby.

Deutsche Bank agrees to provide NRG Energy with any information and additional authorization necessary to effect the release of its security interest in the Released Collateral.
