I, Robert A. Rowan, hereby declare and state as follows:

1. I am an attorney for Taylor Made Group, Inc., a New York corporation, with a place of business at 66 Kingsboro Avenue, Gloversville, New York 12078.

2. On September 3, 2004, Nelson A. Taylor Co. Inc. of 66 Kingsboro Avenue, Gloversville, New York 12078, recorded in the U.S.P.T.O. a Change of Name document to reflect its name change to Taylor Made Group, Inc, which was executed on August 27, 2004.


3. The above-mentioned Name Change Document is recorded at Reel/Frame: 002933/0129 in the U.S.P.T.O.

4. Prior to the name change to Taylor Made Group, Inc., Nelson A. Taylor Co. Inc. had sometimes been known as N.A. Taylor Co., Inc. or N.A. Taylor Company, Inc.
