## PATENT AND TRADEMARK ASSIGNMENT AGREEMENT

THIS PATENT AND TRADEMARK ASSIGNMENT AGREEMENT (this "Agreement") is made as of the 1<sup>st</sup> day of April, 2003 by and between Central Soya Company, Inc., an Indiana corporation ("*Central Soya*"), and Solae Holdings LLC, a Delaware limited liability company ("*Solae*"). This Agreement is made pursuant to the terms of that certain Contribution Agreement dated as of March 31, 2003 by and between Central Soya and Solae (the "*Contribution Agreement*"). Capitalized terms not defined where they appear in the text of this Agreement are defined in Article I hereof. Capitalized terms used but not defined herein shall have the meanings ascribed to them in the Contribution Agreement.

### RECITALS

WHEREAS, the Contribution Agreement provides for the conveyance of certain assets, rights and properties of Central Soya to Solae; and

WHEREAS, pursuant to the Contribution Agreement, Central Soya has agreed to assign its right, title and interest in certain patents, patent applications, trademarks and trademark applications, relating exclusively to the Business, to Solae upon the terms and conditions set forth below and in the Contribution Agreement.

NOW, THEREFORE, in consideration of the foregoing and the representations, warranties, covenants and agreements herein contained and contained in the Contribution Agreement, the receipt and sufficiency of which is acknowledged, Central Soya and Solae agree as follows:

### ARTICLE I

#### DEFINITIONS

##### Section 1.01 Definitions.

As used in this Agreement, the following terms shall have the following meanings (such meanings to be equally applicable to both the singular and plural forms of the terms defined):

"*Central Soya Proprietary Property*" shall mean, without limitation, proprietary property rights of Central Soya, including (a) unpublished patent applications and (b) any inventions, improvements and/or discoveries that may or may not be legally protectable, including all know-how, trade secrets, research plans and priorities, research results and related reports, statistical models and computer programs and related reports, and market interests and product ideas that are necessary to own, operate or use the Contributed Assets as currently owned, operated and used by Central Soya.

*"Member"* shall have the meaning set forth in Section 1.1 of the Amended and Restated Limited Liability Company Agreement of Solae Holdings LLC, dated as of March 31, 2003, by and among E.I. du Pont de Nemours and Company, Central Soya and Solae.

*"Patents"* shall mean (a) the patents and patent applications listed in Exhibit A attached hereto and made a part hereof; (b) any continuations, continuations-in-part or divisionals of (a); (c) any extension, renewal, reexamination or reissue of a patent identified in (a) or (b); and (d) all foreign equivalents of (a), (b) or (c).

*"Trademarks"* shall mean the registered trademarks and applications therefor listed in Exhibit B attached hereto and made a part hereof, and all goodwill associated therewith.

## ARTICLE II

### ASSIGNMENT

#### Section 2.01 Assignment of Patents, Trademarks and Proprietary Property.

Subject to the terms and conditions of this Agreement and the Contribution Agreement, and in accordance with the Contribution Agreement, Central Soya hereby assigns and transfers to Solae, and Solae hereby accepts and assumes from Central Soya, subject to Sections 2.02 and 2.03 hereof, the exclusive entire right, title and interest of Central Soya in and to the Patents, Trademarks and Central Soya Proprietary Property.

#### Section 2.02 Recording of Assignment.

Solae shall be responsible, at its own expense, for the preparation, legalization and recording of any documents and the obtaining of any third-party or governmental approvals or consents not required to be obtained by Central Soya under the Contribution Agreement which may be necessary to effect and record the assignment or transfer of any of the Patents and Trademarks to Solae, and Central Soya hereby appoints Solae as Central Soya's attorney-in-fact, irrevocably and coupled with an interest, to execute, acknowledge, deliver and record any documents or instruments necessary to effect such assignment or transfer.

#### Section 2.03 Delivery of Patents and Trademarks.

Central Soya will use all reasonable efforts to physically deliver one set of the Patents and Trademarks to Solae within thirty (30) days after the Effective Time.

### ARTICLE III

#### MISCELLANEOUS PROVISIONS

##### Section 3.01 Governing Law.

The laws of the State of Delaware, without application of the conflicts of laws principles thereof, shall govern the validity of this Agreement, the construction of its terms, and the interpretation of the rights and duties arising hereunder.

##### Section 3.02 Notices.

Any notice, demand, or communication required or permitted to be given by any provision of this Agreement shall be in writing and shall be deemed to have been delivered, given, and received for all purposes (i) if delivered personally to the party or to an officer of the party to whom the same is directed, or (ii) when the same is actually received, if sent by a nationally recognized overnight delivery service or by registered or certified mail, postage and charges prepaid, or by facsimile, if such facsimile is followed by a hard copy of the facsimile communication sent promptly thereafter by a nationally recognized overnight delivery service or by registered or certified mail, postage and charges prepaid, addressed as follows (or at such other address for a party as shall be specified by like notice):

Section 3.03 Entire Agreement.

This Agreement including the Exhibits hereto, together with the Contribution Agreement, constitute the entire agreement between the parties hereto and contain all the agreements of such parties with respect to the subject matter hereof and thereof. This Agreement supercedes any and all other agreements, either oral or written, between the parties hereto with respect to the subject matter hereof.

Section 3.04 Waiver.

Any failure of a party to comply with any obligation, covenant, agreement or condition herein may be waived by the other party; provided, however, that any such waiver may be made only by a written instrument signed by the party granting such waiver and provided, further, that such waiver or failure to insist upon strict compliance with such obligation, covenant, agreement or condition shall not operate as a waiver of, or estoppel with respect to, any subsequent or other failure.

Section 3.05 Third Party Beneficiaries.

Each Member of Solae (other than Central Soya or its transferees) shall be a third party beneficiary of this Agreement and shall be entitled to the benefits of Solae set forth herein. Except as expressly provided herein, nothing in this Agreement is intended or shall be construed to confer upon any Person, other than the parties hereto and their respective successors and permitted assigns, any rights, remedy or claim under or by reason of this Agreement or any provision contained herein.

Section 3.06 Amendment and Modification.

This Agreement may be amended, modified or supplemented only by a written agreement of each of the parties hereto.

Section 3.07 Successors and Assigns and Assignment.

This Agreement shall be binding upon and inure to the benefit of the parties hereto and their respective successors and permitted assigns; provided, that neither this Agreement nor any of the rights hereunder may be assigned by either of the parties hereto without the prior written consent of the other party.

Section 3.08 Inconsistency or Conflict.

In the event of any inconsistency or conflict between any provision of this Agreement and any provision of the Contribution Agreement, the provision of the Contribution Agreement shall govern.

Section 3.09 Headings.

The article and section headings contained in this Agreement are for reference purposes only and shall not affect in any way the meaning or interpretation of this Agreement.

Section 3.10 Further Assurances.

From time to time, at the request of Solae and without further consideration, Central Soya, at its own expense, will execute and deliver such other documents, and take such other action, as Solae reasonably may request in order to consummate more effectively the assignment of, and to vest in Solae, Central Soya's entire rights, title and interest in and to the Patents, Patent Applications and Trademarks.


