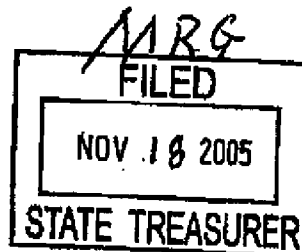

- FIRST:** The name of the surviving corporation is PLIVA, Inc., a New Jersey corporation ("PLIVA"), and the name of the merged corporation is MaddyPharm Inc., a New Jersey corporation ("MaddyPharm").


