## TRADEMARK ASSIGNMENT

This Trademark Assignment ("Assignment"), dated February 8, 2006, is entered into by and between Audio Video Specialists Ltd., a company incorporated in Hong Kong with limited liability, with offices at 8/F New Henry House, 10 Ice House Street, Central Hong Kong, China ("Assignor") and NuVision U.S., Inc., a Delaware corporation, with offices at 7901 E. ### Recitals

A. Assignor is the owner of the common law trademarks and applications to register trademarks listed on Schedule 1, attached hereto (the "Assigned Marks").

B. Pursuant to that certain Subscription Agreement dated February 8, 2006, between Assignor and Assignee, Assignor has agreed to assign its right, title and interest in the Assigned Trademarks in United States and Canada to Assignee as a successor to and as part of the on-going business acquired by Assignee.


Now, therefore, in consideration of the foregoing and the mutual promises, covenants and conditions contained herein, the parties hereby agree as follows:

Assignor hereby assigns to Assignee all right, title and interest, including common law rights, in and to the Assigned Marks in the United States and Canada, including the right to file for protection of the Assigned Marks in the United States and Canada, together with the goodwill of the businesses associated with the Assigned Marks, and that portion of the business which is ongoing and existing to which the Assigned Marks pertain. Assignor agrees to perform, at Assignee's request, all acts and to execute all documents necessary for Assignee to perfect its ownership in and to the Assigned Marks.


