U.S. TRADEMARKS RELEASE OF SECURITY INTEREST

THIS RELEASE dated as of February 10, 2006, by Credit Suisse (formerly known as Credit Suisse First Boston), as Agent (as defined below) for the Lenders. Terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Credit Agreement referred to below.

A. Reference is made to the Credit Agreement dated as of August 20, 2004 (the "*Credit Agreement*"), among CCC INFORMATION SERVICES INC., a Delaware corporation (the "*Borrower*"), CCC INFORMATION SERVICES GROUP INC., a Delaware Corporation ("*Holdings*"), the SUBSIDIARY GUARANTORS party thereto and CREDIT SUISSE (formerly known as Credit Suisse First Boston), as administrative agent and collateral agent (in such capacities, the "*Agent*") and Issuing Bank.

B. Reference is made to (i) the Guarantee and Collateral Agreement, dated as of August 20, 2004 (the "*Guarantee and Collateral Agreement*"), among Holdings, the Borrower, each Subsidiary Guarantor and the Agent in favor of the Agent and (ii) the Trademark Security Agreement, dated as of August 20, 2004 (the "*Trademark Security Agreement*"), among Holdings, the Borrower, each Subsidiary Guarantor and the Agent in favor of the Agent, pursuant to which, among other things, the Borrower granted a security interest to the Agent, for the benefit of certain secured parties named therein, in, among other things, the registered trademarks and pending trademark applications of the Borrower set forth on Annex I hereto (the "*Trademarks*"), which security interest was recorded with the United States Patent & Trademark Office against certain trademarks at Reel 003045 Frame 0779 on September 13, 2004.

C. In connection with the termination of the Credit Agreement, the Borrower has informed the Agent of its desire to obtain the release of all right, title and interest of the Agent, the Lenders and each other grantee or beneficiary in and to the Trademarks granted under the Guarantee and Collateral Agreement and the Trademark Security Agreement.

Accordingly, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, all the Agent's right, title and interest (including, without limitation, security interests) in and to the Trademarks pursuant to the Guarantee and Collateral Agreement and the Trademark Security Agreement shall automatically terminate as provided in the Guarantee and Collateral Agreement and the Trademark Security Agreement, including, without limitation, the Trademarks set forth on Annex I attached hereto, the debt secured thereby having been paid and satisfied in full and any right, title or interest of the Agent in such Trademarks shall hereby cease and become void.
