THIS TRADEMARK ASSIGNMENT AGREEMENT (this "Agreement") is dated as of December 16, 2005, between Wm. Wrigley Jr. Company, a Delaware corporation with a principal place of business at 410 North Michigan Avenue, Chicago, Illinois 60611 ("Assignor") and Farley's & Sathers Candy Co., Inc., a Delaware corporation with a principal place of business at One Sather Plaza, Round Lake, Minnesota 56167 ("Assignee").

W I T N E S S E T H :


